1. No contact to any area of the body.
2. Prior to participating in Kumite, students must know the basic break falls.
3. The following protective gear must be worn (mouthpiece, head, hand and foot gear, groin protection for males, and chest protectors are suggested for females and males).
4. An instructor must supervise matches
5. All Kumite matches will begin and end with a bow.
6. No attitudes will be permitted from anyone.
7. Always be respectful, prior, during and after a match.
8. Official's decisions are final.
9. No face, neck, head or groin contact.

Any violation of these rules will result in the dismissal of any person from any and all activities of the Holland Dojo.
